I understand that any license issued may be revoked or suspended. I further understand that in the event my application is denied, or a license is issued and subsequently revoked or suspended, that I may appeal such denial, revocation, or suspension to the Governing Body. Notice of any appeal must be filed with the City Clerk within 14 days after notice of revocation, suspension or denial of the license has been given to or mailed to such applicant's last known address. The notice of appeal must set forth the ground for such appeal.
