

ORDINANCE NO. 2013-05

AN ORDINANCE PROVIDING FOR THE RANGE OF SALARIES AND COMPENSATION OF VARIOUS CITY OFFICERS AND EMPLOYEES OF THE CITY OF MCLOUTH, KANSAS, AMENDING CHAPTER 1, ARTICLE 3, OFFICERS AND EMPLOYEES AND REPEALING ORDINANCE NO. 2012-02.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MCLOUTH, KANSAS:

Section 1. Chapter 1, Article 3 of the Code of the City of McLouth is hereby amended as follows:

Section 2. SALARIES OF APPOINTED OFFICERS. ~~All appointed officers' salaries are hereby set as follows:~~ The City Council is hereby empowered to set the salaries of all appointed officials within the ranges set forth as follows:


POSITION	SALARY/COMPENSATION RANGE
City Clerk	Between \$25,000.00 and \$50,000.00 annual salary.
City Treasurer	Between \$1.00 and \$100.00 annual salary
City Attorney	A flat fee of \$200 for each regularly scheduled City Council meeting, each regularly scheduled Municipal Court session, and for the first two hours of any occurring trial docket; an hourly rate of \$150 for time beyond the first two hours of any occurring trial docket; an hourly rate of \$150 for attorneys with more than three years experience; an hourly rate of \$125 for attorneys with one to three years experience; an hourly rate of \$50 for law clerks and/or paralegals; regular hourly rates apply to special meetings or special court dockets; mileage reimbursement for travel to and from meetings and court dockets at the prevailing internal revenue service rate at the time of the reimbursement.
Municipal Court Judge	\$3,600.00 annual salary by contract to include one Municipal Court session each month; \$300 for each Trial Docket wherein a trial occurs; \$50 for each Trial Docket wherein the case is disposed prior to the time of trial by plea or dismissal; mileage reimbursement for travel to and from court


	dockets at the prevailing internal revenue service rate at the time of the reimbursement.
Clerk of the Municipal Court	Position held by City Clerk.
City Administrator	Between \$50,000 and \$65,000 <u>\$10,000 and \$30,000</u> annual salary.
Chief of Police	Between \$40,000 and \$60,000 annual salary.
Full and Part-Time Police Officers	Between \$11.00 per hour and \$19.00 per hour.
Utilities Superintendent	Position held by City Administrator. <u>\$23.00 per hour.</u>
Maintenance/Utility Workers	<u>Full Time Employees: Between \$13.00 and \$20.00 per hour.</u> <u>Part Time Employees: Between \$8.50 and \$15.00 per hour.</u>
Animal Control Officer	\$300.00 to \$800.00 by contract

Section 3. Ordinance No. 2012-02 is hereby repealed in its entirety and all other ordinance which may be in conflict herewith are hereby amended to conform to the provisions of this Ordinance.


Section 4. This ordinance shall take effect and be in force after its passage, approval and publication in the official city newspaper. Salaries of appointed officials as set forth herein shall be retroactive to the date of passage.
