## TRAFFIC DIVERSION PROGRAM

**PURPOSE:** The Traffic Diversion Program is designed to address non-DUI prosecutions involving traffic offenses. We believe that by providing this rehabilitative legal opportunity for handling carefully selected traffic offenses, the offenders can become better citizens without sacrificing public safety or the general well-being of the community while making the most efficient use of limited judicial resources.

### **ACCEPTANCE IN THE Traffic Diversion Program IS A PRIVILEGE NOT A RIGHT.**

**ELIGIBILITY:** The City Prosecutor has the discretion to grant or deny participation in the Traffic Diversion Program. The City Prosecutor will place a higher priority on the need to ensure public safety rather than the desires of the individual traffic offender. No presumption in favor of diversion exists in any case. It is presumed that *diversion is not appropriate in the following circumstances:*

- ❖ The Applicant has had a diversion or amendment of a traffic Complaint in the City of McLouth in the 12 months preceding the date of the violation.
- ❖ The current Complaint was issued as a result of an accident.
- ❖ Alcohol is a factor in the current Complaint.
- ❖ The current Complaint is for a speed in excess of 20 mph over the posted speed limit.
- ❖ The current Complaint is for a violation committed in a construction or school zone or involves a school bus or emergency vehicle.
- ❖ The offense was combined with a major traffic offense, including but not limited to driving without having liability insurance in force, driving while suspended, driving while revoked, reckless driving, fleeing or attempting to elude, or leaving the scene/failure to report an accident.

### **FEE, FINES, AND COSTS:**

- ❖ A **\$25.00** non-refundable Traffic Diversion Application Fee, ***made payable to the Simpson, Logback, Lynch, Norris, PA***
- ❖ A traffic fine assessed for the offense as set forth on the Municipal Court approved fine schedule, and a diversion fee that is twice the amount of the traffic fine.
- ❖ Court costs as approved by the Municipal Court, approximately \$85.

- ❖ Costs associated with records requests, approximately \$19.95.
- ❖ A performance evaluation fee of \$60.
- ❖ Fees, fines, and costs must be paid by electronic funds transfer, check or money order. All fees/fines/costs (not including the application fee) are to be ***made payable to the City of McLouth.***
- ❖ Payment arrangements may be made with the City Prosecutor, HOWEVER, **ALL** fees, fines, and costs must be made before the end of the 90 day diversion term.
- ❖ If a payment is made with an insufficient funds personal check, an additional \$30.00 fee will be assessed and no personal checks will be accepted thereafter.
- ❖ Costs for any driving course or drug/alcohol evaluation requirements are to be paid by the defendant and paid directly to the course or evaluation provider.

I understand that I have the right to consult with an attorney and that the City Prosecutor, Municipal Court Judge, and Municipal Court Clerk cannot give me legal advice.

❖ I further understand that by signing this Application for Traffic Diversion I am admitting that I committed the traffic offense(s) alleged in the Uniform Notice to Appear and Complaint.

❖ I request that my Application for Traffic Diversion be approved. I have paid the \$25.00 nonrefundable application fee.
